## FREQUENTLY ASKED QUESTIONS / ADDITIONAL INFORMATION

What is an "E" Parking Permit? An "E" parking permit allows individuals who are employed in Downtown Lindenhurst to park in 101 "E" Permit eligible parking spaces in Downtown Lindenhurst. Vehicles displaying an "E" Permit are not subject to posted time limits and do not have to pay the meter if the "E" space is metered.

What do "E" Permits look like? "E" Permits are "Hang Tags" that must be displayed / hung from the vehicle's rear view mirror when parked in an "E" Permit space. The permit will include the permit number and permit expiration date.

Where are the "E" Parking Permit parking spaces located? "E" Permit spaces are identified by green painted lines and signage in the Village parking lots or stickers on meter poles of eligible on-street metered spaces. The following table identifies these lots and on-street spaces.

What if a vehicle displaying an "E" Permit is parked in a space that is not "E" Permit Eligible? The vehicle will be subject to posted parking time limits and/or parking meter fees just like all the other vehicles.


What if all the "E" Permit spaces in a particular parking lot are full? The Village will limit "E" Permit sales but cannot guarantee that an "E" Permit spaces will always be available. In these cases it is recommended that "E" Permit holders seek parking in an alternate "E" Permit location. There are 101 "E" Permit Eligible parking spaces located throughout Downtown Lindenhurst.

Can cars without an "E" Permit park in "E" Permit spaces? Yes, but only at the on-street (24HR limit) metered spaces. "E" Permit spaces in the Village parking lots are for "E" Permits ONLY during posted time periods.

Can Employees apply as individuals for an "E" Permit and if so, what is the cost? Yes. Any Downtown Employee may purchase an "Individual" permit and the cost is \$16.25 per quarter (\$65 per year).

What if one of my E-Permits is damaged or lost? Bring damaged "E" Permits to the Village Clerk's office and they will issue you a replacement permit at no additional cost. Lost "E" Permits, unfortunately, cannot be replaced and the fee is non-refundable.
