



TEMPORARY FOOD SERVICE ESTABLISHMENT PERMIT APPLICATION 2026

TEMPORARY FOOD SERVICE ESTABLISHMENT: A food service operation from a booth, stand, vehicle, or cart at an event, serving or preparing food for the public. This includes vending pre-packaged or nonhazardous goods from approved equipment carried by the vendor.

WHERE CAN TEMPORARY FOOD SERVICE ESTABLISHMENTS OPERATE IN THE VILLAGE OF LINDENHURST?

- Private property in specific zoning districts
- Special events
- Events sponsored by the Village or a community organization

REQUIREMENTS AND FEES

- Private Property: The property owner must provide permission to the vendor.
- Vendors may operate at one property location for a maximum of three consecutive days; after three days, the vendor must move off of the property
- Vendors must obtain a Village of Lindenhurst Temporary Food Service Establishment Permit from the Village Clerk's Office at Village Hall, 430 South Wellwood Avenue, Lindenhurst, NY 11757.
- **Once the application has been paid for and approved, a mandatory inspection will be scheduled. Code Enforcement will contact the vendor directly to arrange an inspection date.**
- The fees are as follows:
 - o \$30.00 non-refundable application fee
 - o \$100.00 per day, with a maximum of three consecutive days at one location; OR
 - o \$250.00 per year for an annual permit
